Requirements for Application & Participation

1. Please submit an *unedited, unlabeled* audio recording of 5-10 minutes of the auditioning ensemble's performance. Audio recording should display the finest technical, as well as musical abilities by the auditioning ensemble.
 - There is no required music list, however, the audio recording must include **a slow piece, and one other piece of the director's choosing or one piece with contrasting movements.** It is recommended that music is grade II or higher.
 - Performance order should be **Track 1: Slow piece, Track 2: "other."**
 - THREE conductors' scores for each selection must be included. (Photocopies may be submitted as per copyright law.)
 - Tape must be recorded after Aug 31, 2011.
 - Compact discs are highly suggested for best recording results, however high quality audiotapes may be submitted.
 2. Invitations will be issued based on the merit of the audition tape and as recommended by the selection committee. Generally no more than one group may be invited per school. One other performing ensemble from each school may be invited based on availability of performance time slots, as long as the school's premiere group has already been invited.
 - Each invited group must submit a **\$175.00** entry fee upon acceptance to the State Festival.
 - Schools who cannot travel may submit a tape for comments only.
 - The UMEA Junior High State Concert Band Festival chairman reserves the right to schedule all festival performances. Invited Ensembles will be divided into blocks of five for performances. Ensembles are required to be present from the beginning of their performance block to the end.
 3. The application fee is **\$40**. This fee is non-refundable. The fee is designed to offset the costs of evaluators' time and evaluation. Each tape will receive brief comments from leading educators in the state of Utah.
 4. All performers who contribute to the performance **MUST** be students in the ensemble's school. Special guest soloists, who are not students, are allowed but may not perform on pieces for which they are not the guest soloist(s).
 5. The ensemble director and a school official must authorize, with their signatures, approval of this application by signing the application. The director and school official acknowledge that if invited to the event, the applying ensemble will participate and perform a concert not to exceed 40 minutes of music, inclusive of ensemble set changes. **Ensembles MUST also be able to stay for their entire performance block that includes performances by at least two other groups.**
 - Ensembles submitting tapes for "comments only" do not need to have an administrator's approval.
 6. The application and accompanying forms must be postmarked by **January 9, 2012**.
